COUNTY QUESTION

PROPOSITION

Shall the County of Creek, State of Oklahoma, be authorized to make permanent a currently existing county excise (sales) tax of one-third of one percent (0.333%) upon the gross proceeds or gross receipts derived from all sales to any person taxable under the Sales Tax Law of Oklahoma as set out in Resolution No. 2008-28 of the Board of County Commissioners of the County of Creek; said sales tax revenues therefrom shall be used as follows: (A) one-sixth (1/6) of the one percent (0.1667%) sales tax revenues generated shall be transferred to the sales tax revolving fund of the county, and shall be used for the payment of the debt service, including payment of interest and principal and premium, if any, as the same become due, whether at the stated maturity thereof, by acceleration, call for redemption or otherwise, on: (I) indebtedness incurred by the Creek County Public Facilities Authority, the proceeds of which were used to acquire, construct and equip the county jail facility; (II) indebtedness incurred by the Creek County Public Facilities Authority, the proceeds of which are to be used to acquire, construct and equip a Juvenile Justice Center; and (III) indebtedness incurred by the Creek County Public Facilities Authority, the proceeds of which are to be used to finance capital improvements to various county buildings and the county highway system; and (B) one-sixth (1/6) of the one percent (0.1667%) sales tax revenues generated shall be transferred to the sales tax revolving fund of the county, and shall be used for the operation and maintenance of the Juvenile Justice Center and all necessary and related services of said Juvenile Justice Center; with said one-third of one percent sales tax to become effective on or after January 1, 2009; all as set forth in said resolution No. 2008-28, a copy of which is on file with the county clerk of the County of Creek?
